THE BOARD OF SUPERVISORS OF THE COUNTY OF SIERRA ORDAINS as follows:

Ordinance Section One: NON-CODIFIED FINDINGS AND BACKGROUND

THE BOARD OF SUPERVISORS OF THE COUNTY OF SIERRA FINDS THAT:

1. To the greatest extent possible, user fees, when allowed by law, should cover the cost of providing the services.
2. The various County departments, in conjunction with the Auditor's office audit and calculate the costs of providing the various permits and services of the departments.
3. The fees and charges adopted hereby are based upon the cost of services within the criminal justice system, which service costs may be recovered from those with capacity to pay such costs when authorized by order of the Court.
4. Also included in the Schedule are fees charged by the various departments for other activities outside the criminal justice system, in order to provide a clean schedule of departmental fees.
5. Page numbers on the schedule pages refer to the larger fee schedule. Page numbers at the bottom of the page refer to this Ordinance No. 817.

Ordinance Section Two: NON-CODIFIED PROCEDURAL DIRECTIVE

The fees and charges for the activities of the various County Departments and Agencies shall be as shown or referred to in the "Schedule of Sierra County Fees and Charges", which shall be maintained on file with the Sierra County Clerk/Recorder.

Ordinance Section Three: Part 5, Chapter 50, Section 010 of the Sierra County Code is hereby amended to read as follows:

**Ordinance Section Four:** This ordinance shall take effect thirty (30) days after its passage. Before the expiration of fifteen (15) days after passage of this ordinance, it shall be published once with the names of the members of the Board of Supervisors voting for and against the ordinance in the Mountain Messenger, a newspaper of general circulation published in the County of Sierra, State of California.
